Strengthening Muslim charities & charitable giving - In 2009, Muslim Advocates conducted a robust educational program for leaders of Muslim nonprofits, providing technical assistance and hosting educational seminars and webinars on nonprofit good governance and accountability. Muslim Advocates also assisted charities with securing accreditation from the Better Business Bureau-Wise Giving Alliance, a trusted charity evaluator. Muslim Advocates educates Muslim nonprofit leaders about the BBB-WGA standards of accountability and assists them with BBB-WGA evaluation.

Ending racial and religious profiling - In 2009, Muslim Advocates educated American Muslims about the law and their rights, as well as policymakers and the public about the impact of national security policies on the freedoms of law-abiding Americans. Muslim Advocates published a report documenting incidents of American Muslims returning from international travel who are stopped by federal agents at the border and searched and interrogated without suspicion of wrongdoing. Muslim Advocates also sought disclosure of the FBI's surveillance guidelines and protocols, through a Freedom of Information Act request.
